We provided comprehensive services to 514 seniors 60 & older in Durham with incomes below 200% of the FPL. They benefited from medication therapy management with our clinical pharmacists trained in geriatrics, Medicare insurance counseling, and tailored community referral to support independence. We helped 167 apply for or sustain the 'full' federal low-income subsidy for medications and 347 received our direct financial assistance to help pay for medicines. We provided face-to-face Medicare insurance counseling to an additional 1,287 Medicare beneficiaries and 426 individuals received tailored referrals to other programs, primarily the drug manufacturers assistance programs. Five individuals above 200% FPL paid for comprehensive medication reviews on a sliding scale.
